Wedding Planning 101

The Wedding Professionals of Central Florida is hosting a seminar for brides and grooms at The Ballroom at Church Street on Thursday, September 21 from 6-9 pm.

Each vendor will rotate around the room every 6-7 minutes and take a seat at a table that is set for eight to ten brides and grooms.
